ANNA ALEXANDER is Research Fellow and Lecturer at the Simone de Beauvoir Institute, Concordia University, Montréal. She is the editor of The Simone de Beauvoir Institute Review Vols. 18/19 (2001), special issue on Beauvoir's "Heritage In-Situ" and is currently working on a book on Beauvoir's queer ethics entitled *Must We Burn Beauvoir? Her forthcoming co-edited collection *High Culture: Reflections on Addiction and Modernity*, for the Philosophy and Contemporary Culture Series, (Albany: SUNY Press), extends her work on Beauvoir into the fields of philosophy, cultural studies and the ethics of addiction.

NGWARSUNGU CHIWENGO is Associate Professor of English and Director of the World Literature Program at Creighton University. She has published articles in African and African American literatures and Congolese cinema, and has a book in progress on Peter Abrahams.

DAI JINHUA teaches at the Research Institute for Comparative Literary and Cultural Studies at Peking University and is an adjunct professor of Chinese Literature in the Department of East Asian Languages and Literatures at The Ohio State University. Professor Dai teaches Chinese film, women's literature, and popular culture. She has published prolifically on film, film theory, women's literature, and popular culture.
